**WHEREAS**, the Waldo and Branches Intercounty Drain is an intercounty drain located in Midland County and Bay County, established pursuant to the Michigan Drain Code, Public Act 40 of 1956, as amended; and

**WHEREAS**, Larkin Charter Township has determined that the consolidation of the Waldo and Branches Intercounty Drain Drainage District, Beckman Intercounty Drain Drainage District, and Ott Intercounty Drain Drainage District is necessary for the public health of Larkin Charter Township; and

**WHEREAS**, Larkin Charter Township recognizes that it will be liable for an assessment at large against it for a percentage of the cost of the proposed consolidation, maintenance and improvement.

**NOW, THEREFORE BE IT RESOLVED THAT**, Larkin Charter Township does authorize the filing of a petition for maintenance and improvement of the drain as provided in Chapter 8 of Public Act 40 of 1956, as amended.

**BE IT FURTHER RESOLVED THAT** the Supervisor is authorized to execute the petition for the maintenance and improvement of the drain.

**BE IT FURTHER RESOLVED** that the Clerk shall forward to the Midland County Drain Commissioner a copy of this Resolution for the petition for maintenance and improvement of the drain.
